- ◆ *By post*—Mail to GPO Box 744 Sydney NSW 2001.
- ◆ *Direct deposit*—Donate directly into the NPBF account: Commonwealth Bank, BSB 062000, Account no. 11529555.
- ◆ *In the USA*—Send funds in \$US to Self-Realization Fellowship (3880 San Rafael Ave, Los Angeles, CA 90065, USA) with a note for it to be placed in the Sydney Centre Building Fund account that is held at SRF International Headquarters.

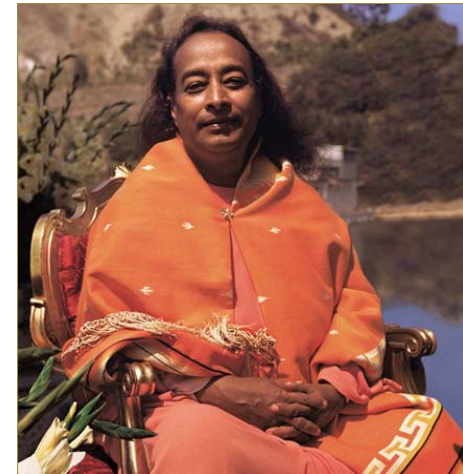

What is the purpose of the Trust?

The New Premises Building Fund (NPBF) Trust was set up in 2004 so that devotees wishing to donate or make a bequest to purchase a permanent meeting place for Sydney Centre of Self-Realization Fellowship (SRF) could be assured that the money would be used solely for that purpose.

Why a Trust Deed?

Setting up a Trust provided a legal and financial framework for dedicated NPBF funds. The Trust Deed was drawn up in consultation with legal advisers in Sydney and the SRF International Headquarters' Legal Department. Five Trustees, elected by members of the Sydney Centre, are legally bound to hold the dedicated funds in trust for Sydney Centre members, in accordance with the terms of the Trust Deed.

Who has final ownership?

Any premises purchased will become the property of Self Realization Fellowship Church headquarters in Los Angeles (Mother Center).

Four of the five trustees must sign any cheque for outgoing monies for the new premises purchase, and only after Mother Center and Sydney Centre member approval processes have been completed.
